Journey to the heartland of the ancient Silk Road and to the oasis cities of Central Asia associated with Alexander the Great, Genghis Khan and Tamerlane. Today Uzbekistan is a young nation, a melting pot of different cultural ethnic groups. Travel along the Silk Route that once saw camel caravans laden with silk and spices. Our trip begins in Tashkent, capital of Uzbekistan. Visit the historic old walled town of Khiva with its fantastic architecture and magnificent Bukhara. Continue along the Silk Route by the Royal Road to legendary Samarkand. Throughout we explore its rich cultural and architectural inheritance, visiting museums and important archaeological and historic sites, wandering through bustling markets, meeting artisans in their homes and workshops who produce exquisite textiles and crafts. Our visits include suzani embroiderers, papermakers, gold thread embroiderers, jewellers, carpet weavers, woodcarvers, ceramicists, natural dyers and weavers of silk and ikat as well several local markets. Opportunity in Bukhara for a fabulous Master Class in suzani embroidery. Join us on a tour of a lifetime!

Day 1 Tue, Sep 13: Group international flight from London Heathrow to Tashkent accompanied by Lesley Robin, can be booked with our travel agency or you can make your own independent air arrangements to meet up with the group. For your comfort our rooms have been reserved from 12noon today due to our very early arrival in Tashkent tomorrow morning. TASHKENT – HOTEL GRAND ORZU

Day 2 Wed, Sep 14: Flight arrives Tashkent around 5am when we will be met by our tour escort Raisa Gareeva who will accompany us throughout our time in Uzbekistan. Morning to rest after our overnight flight. After an early lunch, orientation sightseeing by bus includes a visit to the Fine Arts Museum with exquisite suzani embroideries and other traditional crafts. Evening special welcoming dinner in the private studio and workshop of one of the finest ceramic artists in the country. TASHKENT – HOTEL GRAND ORZU (B,L,D)

Day 3 Thu, Sep 15: Visit the Museum of Applied Arts displaying a great range of folk art as well as contemporary art. Visit the Uzbek Puppet Theatre. Afternoon flight to Khiva, the most remote and intact of Central Asia's Silk Road cities. KHIVA – HOTEL MALIKA (B,L, D)

Day 4 Fri, Sep 16: A full day exploring this museum city that houses the most homogenous collection of architecture in the Islamic world and the historic old walled town with its narrow streets. Visit a family of woodcarvers, a carpet weaving cooperative and a silk weaving workshop. Evening dinner with folk music and dance. KHIVA – HOTEL MALIKA (B,L,D)

Day 5 Sat, Sep 17: A full day's drive across the immense Kyzyl Kum Desert (its name meaning 'Red Sand' and divided between Uzbekistan, Kazakstan and Turkmenistan) to Bukhara, the most complete example of a medieval city in Central Asia with its mosques and minarets. Our hotel is situated in an historic neighbourhood providing an opportunity to walk and visit the nearly metalsmiths and small workshops for painting, musical instruments and embroidery. Due to a limited number of rooms, single accommodation may not be available for our 5 nights in Bukhara. BUKHARA – HOTEL SALOM INN (B,L,D daily)

Day 6 Sun, 18: A full day's walking tour of Bukara includes visits to the Fortress Ark where the Emirs once lived, Ismail Samani Mausoleum, a masterpiece of 10th century Islamic architecture, Chashma Ayub – the Spring of Job, mosques, medressahs (a place where learning or studying is done) dating back to the 17th century and the nearby covered markets. Dinner at a local chef's house where we learn about traditional cuisine. BUKHARA – HOTEL SALOM INN (B,L,D)



Day 7 Mon, Sep 19: Morning excursion to the Summer Palace with its fine collection of costumes, silver, Ming china and Bukharan textiles. Afternoon visit Sadbarg Centre which focuses on the education and training of young people in the traditional crafts of sewing, weaving and gold silk embroidery using ecological natural fabrics. BUKHARA – HOTEL SALOM INN (B,L,D)

Day 8 Tue, Sep 20: Our morning's visits include the Craft Centre housed in an old caravan sarai where we see demonstrations of many Uzbek crafts including miniature painting, woodcarving, puppet making and jewellery. Visit Akhmad Arabov, a well-known suzani embroiderer. The afternoon is free to wander the old trading domes which are now daily bazaars filled with textiles... carpets, suzani embroideries, silk ikat, hats and traditional dress. BUKHARA – HOTEL SALOM INN (B,L,D)

Day 9 Wed, Sep 21: This morning a Master Class in suzani embroidery has been arranged at the UNESCO School of Carpet Weaving and Natural Dyes. Suzanis were traditionally made by Central Asian brides as part of their dowry and presented to their husband on the day of the wedding. The name is derived from Persian meaning 'needle'. Chain, satin and buttonhole stitches are the primary stitches used as well as couching. Zarina Kendjaeva, a skilled embroiderer will demonstrate and explain the traditional techniques and designs used and fabric, threads and needles provided so that you can make your own sample piece. Later visit a collector and textile expert as well as the workshop of a traditional jeweller. BUKHARA – HOTEL SALOM INN (B,L,D)

**Day 10 Thu, Sep 22:** We continue tracing the Silk Route to legendary Samarkand along the Golden Road stopping in Gizhduvan, an important ceramic centre. Visit a family of potters who grind their own glazes using a mule-driven grinding wheel. After a home-hosted lunch drive to Shafrikan and visit a suzani artist. Arrive in Samarkand early evening, our base for the next 4 nights. SAMARKAND – MALIKA PRIME HOTEL (B,L,D)

Day 11 Fri, Sep 23: Samarkand, resonant with romantic legend was conquered by Alexander the Great, the Mongol Genghis Khan and above all, Tamerlane. It has been called many names from the Mirror of the World to the Pearl of the East and the Jewel of Islam. Morning excursion to Gur Emir where Tamerlane is buried and visit a silk paper making workshop that uses techniques little changed over the centuries. Afternoon explore Samarkand visiting Registan Square and the medrassahs, the mausoleums of Shah-i-Zinda with its exquisite blue tilework, the Bibi-Khanum mosque and a nearby market. Dinner at the home and studio of Valentina Romanenko, a talented suzani designer. SAMARKAND – MALIKA PRIME HOTEL (B,L,D)

Day 12 Sat, Sep 24 & Day 13 Sun, Sep 25: Saturday full day excursion to Shakhrisyabz, birthplace of Tamerlane where our visits include the Ak Saray White Palace, the Jehangir mausoleum and the Kok-Gumbaz mosque. Later we meet silk embroiderers in their workshop. Sunday drive to the busy weekly market in Urgut, a small town at the foot of Zarafshan Mountains where people come from the surrounding countryside to buy and sell and enjoy food freshly made at little stalls. There are smithies and tin workers, old and new crafts including suzanis, carpets, jewellery and ceramics. Afternoon visit a silk carpet weaving workshop using traditional patterns. SAMARKAND – MALIKA PRIME HOTEL (B,L,D daily)

**Day 14 Mon, Sep 26:** Begin our day with a visit to a medieval observatory created by Tamerlane's learned grandson. Drive to Tashkent through the mountainous countryside with stops to photograph en route. Evening attend a performance at the Navoi Opera and Ballet Theatre. TASHKENT - HOTEL GRAND ORZU (B,L,D)

Day 15 Tue, Sep 27: Depart for Kokand situated in Ferghana Valley. The valley is unique as many traditional craftspeople can still be found working in the small Uzbek villages. Visit the Khan's palace museum, mosques and medrassahs. Continue to Rishtan, one of the most important ceramic centres in Central Asia since ancient times, where we visit the private studio of a Master ceramic artist and learn about the traditional floral designs of the region. FERGHANA – HOTEL CLUB 777 (B,L,D)

Day 16 Wed, Sep 28: After breakfast we take a walking tour of Ferghana. Drive through a landscape of mulberry trees to Margilan, known for its Fergana style of architecture and a major centre for silk production using distinctive colours and patterns. See the age-old method of silk production and meet Masters of their craft. Visit Jodgorlick silk weaving factory to see all processes of silk weaving as well as a workshop for velvet ikat. Visit the studio of Salijon Akhmadaliev for traditional wood block printed cloth. FERGHANA - HOTEL CLUB 777 (B,L,D)



**Day 17 Thu, Sep 29:** Flight to Tashkent. Visit the vibrant Chor-Su market situated in the Old City. This evening we come together for our farewell dinner. TASHKENT – HOTEL GRAND ORZU (B,L,D)

Day 18 Fri, Sep 30: Rooms are reserved until 12noon today. Our early morning international flight departs Tashkent and arrives back the same day at Heathrow Airport.

Her knowledge of eastern culture, Hinduism and Buddhism and her interest in the textile heritage and crafts of the Indian sub-continent is a result of her extensive travels throughout the region and beyond. She is delighted to be accompanied by Raisa Gareeva on this trip of a lifetime!

UZBEKISTAN TOUR ESCORT: Raisa was born in Bukhara, Uzbekistan and graduated from Bukhara University with a Masters Degree in Russian and English. For many years she worked with Intourist, the state-run travel company of the former USSR. After the USSR collapsed Raisa started her own innovative travel company. Raisa is truly a "gem" and her relationship with the craftspeople of her country, her knowledge and life experiences are phenomenal.

#### Making your booking

Please fill in the booking form and send it to us together with the deposit or full payment if booking within 9 weeks of departure. Provided the holiday is available we will make all arrangements and send you confirmation of your booking and all relevant details. It is from then on that a firm contract exists between you and CTT Group Ltd T/A CT Group & Incentive Travel, on the basis of the itinerary sent to you. If the holiday is not available, we will return your deposit or full payment. Once we have confirmed your booking, your deposit is non-returnable except in the special circumstances mentioned below. We will send you a final invoice about 11 weeks before departure and this will show any surcharges due. You must pay the amount due within 10 days of the invoice date. We may otherwise treat the booking as cancelled and apply our cancellation charges. We send you your tickets about 10 days before you go.

#### What your money buys

The holiday price includes: If requested with us at the time of booking, economy class air travel, at the lowest quoted fare; sometimes if seats in this category are no longer available, we will have to charge a supplement. Twin or double-bedded room with private bath or shower at the named hotels or substitutes of the same standard. Meals as specified. Meetings, transfers and surface transportation by car, bus or train. Holiday prices cover only the services and duration shown on each itinerary. Check-out time from rooms is generally 12 noon. Where, for reasons of force maieure, altered services are taken or the duration of the holiday is extended, we reserve the right to pass on additional costs in full. #### **Delays at Point of Departure**

The scheduled airlines we use will generally provide meals and accommodation to passengers already checked-in in the event of extended delays. The CTT Group t/a CT Groups and Incentives and or The Guild cannot be Embroiderers' held responsible for any alterations that are necessary as a result of any delays caused directly or indirectly to the international flights for reasons within or outside of theirs or the carriers control.

#### Passports, Visas and Health

You must have a full British passport valid for at least 6 months beyond your return date and one blank page in your passport. If you do not travel on a British passport or do not meet these requirements or have any doubt as to your legibility to enter Uzbekistan then please contact us for further advice before confirming your booking.

#### Age and Health

We do not operate any age limit on our holidays. However if you are aged over 80, we do require that you should be travelling with a companion. In many of the countries in which we operate, medical facilities are poor, and if you do fall ill, appropriate treatment may be difficult to access. There are no formal health requirements except for those who have recently visited a Yellow Fever area. Recommended precautions will be advised with the confirmation of booking. All clients are themselves responsible to ensuring that they conform to the health regulations regarding vaccinations.

Surcharges – Our Policy
Our prices are based on tariffs, exchange rates and other costs as at 1st August 2010 and specifically on a rate of £1 =  $\overline{US}$  \$1.45. The price of your holiday is subject to surcharges on the following items for increases in: transportation costs, e.g. scheduled airfares and any other airline surcharge which are part of the contract between airlines (and their agents) and the tour operator, government action such as increases in VAT or any other government imposed increases, currency in relation to adverse exchange rate variations, fuel for road vehicles. Even in these cases we will absorb an amount equivalent to 2% of the holiday price, which excludes insurance premiums and any amendment charges. Only amounts in excess of this 2% will be surcharged. If this means paying more than 10% on the holiday price, you will be entitled to cancel your holiday with a full refund of all monies paid except for any deposits paid to the airline which in some circumstances may be non refundable, and any premium paid to us for holiday insurance and amendment charges. Should you decide to cancel because of this, you must exercise your right to do so within 14 days from the issue date printed on the invoice.

#### If you have to cancel

If you find you cannot take your holiday and have to cancel for whatever reason, your deposit will be forfeited. If you cancel, we must impose cancellation charges up to a maximum as follows: between time of booking and 70 days before departure loss of deposit, between 69 - 42 days before departure 30 % between 41 – 28 days before departure 40%, between 27 - 14 days before departure 60%, between 13 – 7 days before departure 80% and between 6 days and departure 100%. Percentages are of total holiday cost. If you are obliged to cancel, you may with reasonable notice, transfer your booking to a third party who satisfies all the conditions required by a person taking that holiday, but you will be obliged to pay for any additional costs resulting from the transfer. Travel insurance is absolutely required to come on the tour. Please make sure it includes cancellation & repatriation (please ask if you need advice on travel insurance).

We will do our utmost to provide the holiday arrangements that have been confirmed, but we must reserve the right to modify or cancel any holiday, flight schedule, accommodation or arrangement if unforeseen circumstances arise.
